4. Executive Summary (To be taken from written report)

This decision relates to the exercise of the delegated authority given to the Chief Executive by Cabinet on 19 March 2018 to issue formal consent to the making of the Order by the Secretary of State establishing the North of Tyne Combined Authority following consultation with the Elected Mayor and Monitoring Officer.

The North East Combined Authority (NECA) and its constituent authorities in consultation with the Ministry for Housing, Communities and Local Government have been instrumental in the drafting of the Order changing the boundaries of NECA and the establishment of the North of Tyne Combined Authority.

The report attached to this Decision Record attaches the draft Newcastle Upon Tyne, North Tyneside and Northumberland Combined Authority (Establishment and Functions) Order 2018 and deals with the contents of the draft Order in more details.
